£6million Trees Call to Action Fund now open

The fund – distributed on behalf of Defra – will help green projects in England to create woodlands, develop partnerships and skills and improve people's access to nature.

Grants of between £250,000 to £500,000 will be available to projects that can increase woodland cover, and which support the Government's <u>England Trees Action Plan</u>. At least three awards are expected to be new regional woodland creation partnerships.

To increase capacity and skills in the forestry sector, the fund also invites projects to engage people with trees, increase access to woodland, create new jobs and develop skills and knowledge.

The £6m Trees Call to Action Fund will be targeted at regions, activities and costs which cannot be supported through other Defra grants.

We are distributing the Trees Call to Action Fund on behalf of Defra's Nature for Climate Fund Programme, working in partnership with Forestry Commission.

Who can apply

Organisations that can help deliver the Government's vision for trees at regional and national scales are encouraged to apply. Applicants will need to set out how their proposals can deliver over the next three years.

The fund will be open to applications from partnerships led by:

- environmental charities
- environmental not-for-profit organisations
- local authorities
- Areas of Outstanding Natural Beauty and National Park Authorities

Projects should contribute to multiple England Trees Action Plan objectives, which comprise:

- expanding and connecting our trees and woodlands
- trees and woodlands as part of the green economy
- protecting and improving our trees and woodlands
- connecting people with trees and woodlands

How to apply

The Trees Call to Action Fund is now open for Expressions of Interest. The deadline is **12 noon on 16 November 2021.** Please read our <u>full application guidance</u>.
