SCFF - Sickle Cell Family Festival

Applicant: Africanise UK Ltd

Project description: raise awareness of sickle cell disease, fitting in with the local authority's cultural strategy and programming.

Decision: Reject

St Mabyn Peace Memorial Hall Centenary Tapestry Project

Applicant: Saint Mabyn Peace Memorial

Project description: mark the centenary of the opening of St Mabyn Peace Memorial Hall. Create a commemorative tapestry and hard back book, record oral histories and hold workshops.

Decision: Award grant of £7,500

Persistence and Change: The continuing story of the British Adventure Playground

Applicant: Assemble Studio CIC

Project description : create a film focusing on the contemporary and historic importance of adventure playgrounds. A range of interviews across four generations will be showcased in venues across Britain.

Project description: research, record and celebrate the heritage of the church and Bexhill-on-Sea, in East Sussex, with the longer-term aim of transforming the church into a community hub.

Project description: support 50 adults in Manchester, London Nottingham who have experienced homelessness to explore their city's heritage. Includes eight history workshops/talks, five guided museum tours and six archive sessions.

Wren's London 300

Applicant: Urbanwise.London Limited

Project description: introduce new audiences to the work of Sir Christopher Wren, particularly highlighting his perseverance in the face of opposition to St Paul's Cathedral, and focusing on themes of resilience and life in 17th century London.

Historic Fountain Restoration

Applicant: Priddy Parish Council

Project description: restore a fountain dating from 1865 situated on the communal green in the centre of the village.

#DYC Object Lessons: Youth Culture Takes Shape

Project description: A Dynamic Collections project to strengthen collections management, object handling, cataloguing, access, skills-development and conservation techniques, alongside delivering a programme of activities.
