### Queens of the City

Applicant: LGK in the community

Project description: This project will celebrate the history of migration to Walsall through the stories of women from both newly arrived and established communities with a focus on migrant journeys, heritage through food, archive illustrations and pictures.

Decision: Award grant of £195,158 (82%).

#### **Coastal Community Matters**

Applicant: The Time and Tide Bell Organisation Ltd

Project description: This project will bring to life the memories of people living in a broad range of coastal communities around the UK by recording varied memories from older people, making them readily accessible in multiple ways and developing a series of educational activities.

Decision: Award grant of £250,000 (100%).

#### **Golden Valley Pilgrim Way**

Applicant: Abbeydore Deanery Council

Project description: This project will enhance the Golden Valley Pilgrim Trail in Herefordshire. They aim to increase the number of people visiting and create a sustainable community business for the churches on route.

Decision: Reject

#### **Raise the Roof at All Saints Church Alrewas**

Applicant: The Parochial Church Council of the Ecclesiastical Parish of All Saints, Alrewas, Staffordshire

Project description: This project will replace the lead roof of the nave of this Grade I listed Staffordshire church and engage the local community with mapping and interpretation of the decorative ceiling.

Decision: Reject

#### **Re-connect**

Applicant: Luton Cultural Services Trust

Project description: This resilience project will review the community needs and organisational sustainability of three heritage sites across Luton.

Decision: Award grant of £177,513 (90%).

#### Pavilions for Music - bringing the nation's bandstands back to life - phase one

Applicant: Parks for People CIC

Project description: This project will help bring the nation's bandstands back to life by raising awareness of opportunities that exist to use them – before we lose them.

Decision: Reject

#### **Memories of Living Well Together**

Applicant: St Philip's Centre Ltd

Project description: This project will preserve and share the recollections and experiences of some of Leicester's diverse, multi-faith communities, both long-term residents and migrants to the city through oral histories, educational work and a museum exhibition.

Decision: Award grant of £163,496 (100%).

#### Grow Wild Seasons: empowering disability through wildlife heritage volunteering

Applicant: Grow Wild Outreach CIC

Project description: This project will engage individuals in Northamptonshire with disabilities, mental health needs and neurodiversity in year-round conservation activities, offering them the chance to learn about and contribute to local wildlife and natural heritage.

Decision: Award grant of £90,352 (37%).

#### Haydn Road Heritage Project

Applicant: Castle Cavendish Foundation

Project description: This project will celebrate the history and heritage of the Haydn Road Pavilion and Sports Ground in Nottingham which dates from 1914. They will explore its archive and oral histories from local communities.

Decision: Award grant of £50,458 (100%).

#### African Rhythms: tracing heritage through dance

Applicant: African Women Impact UK CIO

Project description: This Walsall-based project will preserve and promote the rich cultural heritage of East Africa, through a series of events aimed at raising awareness of dance traditions and promoting intercultural dialogue within the local community.

Decision: Reject

#### 'Tilley' Manea Pump Fire Tender

Applicant: Manea Parish Council

Project description: This Cambridgeshire project will restore and display a 19th century pump fire engine.

Decision: Reject

#### **Crich Tramway Village – foundations first**

Applicant: The Tramway Museum Society

Project description: This resilience project will allow this Derbyshire organisation to refresh their Business Plan's strategic goals, improve audience understanding, support volunteer recruitment, enhance collections care and improve the visitor offer of the National Tramway Museum. Decision: Award grant of £83,875 (94%).

#### Restoration of the Church of St Philip and St James Hallow

Project description: This project will restore the Grade II\* Church of St Philip and St James in Hallow, Worcestershire.

Project description: This Suffolk-based project aims to educate and inform non-Roma people about the cultural traditions and heritage of the Roma community.

Decision: Reject

#### Securing a Sustainable Future for the Home of Children's Play

Applicant: Wicksteed Charitable Trust

Project description: This project will create a sustainable future for Wicksteed Park in Kettering, ensuring it remains a place where people of all generations and backgrounds can meet, play and explore for free, enjoying the positive wellbeing benefits of green space.

Decision: Award grant of £250,000 (95%).

#### **All Saints Community Facilities**

Applicant: The Parochial Church Council of Acton Trussell with Bednall

Project description: This project will make internal changes to the Grade II\* listed All Saints Church in Staffordshire to enable the continued use of the church and to develop its community offer and organisational sustainability.

Decision: Award grant of £236,995 (68%).

#### Renovate, Refresh, and Reimagine – phase one

Applicant: Sir John Moore's School and Exhibition Foundation

Project description: This project will carry out a number of surveys and examine the organisational health of this north west Leicestershire organisation, with a view to developing a wider capital repair scheme for its Grade I listed building and museum in the future.
