## National Lottery Heritage Grants

### **BAME Women Sewing Skills and Fashion Exhibition.**

Applicant: The Economic Forum For Family Empowerment Scotland

Project description: To provide training opportunities for women from minoritised communities in traditional African and Asian sewing techniques, with the aim of preserving cultural heritage and developing skills.

Decision: Reject

### **The Story of the Old Kirk of Kilmarnock, a Loch Lomondside Parish**

Applicant: Kilmarnock Old Kirk Trust

Project description: This project aims to build a sustainable future for the Old Kirk of Kilmarnock by adapting and fitting out the building as a community space and heritage hub.

Decision: Award grant of £245,244 (50%)

### **Conservation and Restoration of Maryfield Tram Depot**

Applicant: Dundee Museum of Transport

Project description: To conserve and restore the 1901 section of the tram depot, safeguarding and securing the future of an important historic building that has been at significant risk for over 20 years.

Decision: Award grant of £250,000 (12%)

### **Resilient Futures**

Applicant: Galloway and Southern Ayrshire Biosphere Partnership

Project description: This project aims to improve the organisation's sustainability by employing two new members of staff, a fundraising manager and business manager, to reduce their reliance on public funds and

develop their own income stream through their business entity, Biosphere Enterprise.

Decision: Reject

## **SUSTAIN:ENGAGE**

Applicant: Grampian Hospitals Art Trust

Project description: Improving public engagement with, and sustainability of, NHS Grampian's collection of artworks.

Decision: Award grant of £57,865 (52%)

## **Preservation and Enhancement of Isobel Fraser Home and Garden**

Applicant: Isobel Fraser Home

Project description: This project seeks to establish a programme of essential maintenance works on the care home building, along with garden works which will improve the environment for residents and provide opportunities for outdoor activities.

Decision: Reject

## **SIAF Dusherra 2024 and 30th Anniversary**

Applicant: Scottish Indian Arts Forum (SIAF)

Project description: To promote social cohesion within the Indian diverse communities living in Edinburgh through sharing the Indian culture events, and through the 30th Anniversary Dusherra event.

Decision: Award grant of £30,000 (69%)

## **Unlocking the Potential of The Hunterian: The Changing Museum**

Applicant: The Hunterian, University of Glasgow

Project description: Undertake a scoping project for the development of a potentially phased plan for the renovation of both the Hunterian Museum within the Gilbert Scott Building and the Hunterian Art Gallery in the William Whitfield Building, futureproofing both buildings for generations to come.

Decision: Award grant of £249,820 (41%)

## **The Enterprising Heritage Project**

Applicant: YMCA Tayside

Project description: Connecting new people, young and old, to their physical and community heritage, educating them and allowing them to consider ways in which they can participate and be more engaged in their heritage.

Decision: Award grant of £100,267 (86%)

### **Conservation Shed (contribution)**

Applicant: Kingdom of Fife Railway Preservation Society

Project description: This project seeks to construct a new conservation building to store, display and maintain KFRPS' railway stock.

Decision: Reject
