Ros Kerslake, Chief Executive of The National Lottery Heritage Fund, has been awarded a CBE in the Queen's Birthday Honours for services to Heritage.

Ros has been CEO of The National Lottery Heritage Fund since July 2016. She was previously CEO of The Prince's Regeneration Trust.

## Ros at The National Lottery Heritage Fund

During Ros’s time at The National Lottery Heritage Fund she has overseen more than £1bn of National Lottery funding awards to the UK heritage sector, including for Paisley Museum, [Hull Maritime City](#), The Fitted Rigging House at Chatham Historic Dockyard, Bevis Marks Synagogue, Templemore Baths in Belfast, and the National Broadcast Archive for Wales.

She has also led the transformation of The National Lottery Heritage Fund, strengthening its leadership role and innovation, and bringing in a new five-year [Strategic Funding Framework](#).

In response to the COVID-19 crisis, The National Lottery Heritage Fund launched a £50m [Heritage Emergency Fund](#), awarding grants to 950 organisations across the UK affected by the crisis.



Ros has also overseen the distribution of substantial Government funding to support organisations through the crisis – the £92m [Culture Recovery Fund for Heritage](#) and the £40m [Green Recovery Challenge Fund](#), to support the nature and environmental sector.
