# **Grant increase requests**

St Johns Church (Worksop) Spire Repair to safeguard our Heritage

Applicant: The Parochial Church Council of St John the Evangelist Worksop

Project description: This project will restore the spire and roofs of the Grade II listed St John's Church, which lies at the centre of Worksop, Nottinghamshire. A range of heritage-focused activities will be run throughout the project.

Decision: Award grant increase of £121,477 to make a total grant of £368,312 (67%)

Project description: This project will support the organisational resilience of the International Bomber Command Centre. Key outputs include the scoping of future capital works and the development of a post-war archive for outreach purposes.

Project description: This project aims to showcase African culture to the community through a traditional skills training programme and sharing the heritage embedded in African clothing.

Decision: Award grant of £10,000 (100%)

### Harwich Redoubt Pilot Repair Project

Applicant: The Harwich Society

Project description: This pilot project seeks to establish a comprehensive approach to the conservation of the Redoubt Fort following consultation with Historic England. Alongside repair works, the project will involve doubling visitor numbers and diversifying their audience profile, with particular focus on engaging with young people and providing skills development to their volunteers and visitors.

Decision: Award grant of £246,538 (66%)

### **School Therapy and Community Allotment**

Project description: This natural heritage project will create a school allotment and restore a historic pond. Activities are planned that the local community can be involved in.

Project description: Building on a two-year community initiative, this landscape and nature project aims to develop 20 community green spaces around Bishop's Castle and surrounding areas.

Project description: This project will research the heritage of Birmingham's music scene, bringing together a diverse community to create and perform new songs that will help educate people about the city's history as part of a wider festival.

Decision: Award grant of £9,998 (13%)

### The Highlife Centre Heritage Resilience Project

Applicant: The Highlife Centre Ltd

Project description: This project will allow The Highlife Centre to build upon the findings of a previous project to develop organisational resilience. The research will explore the benefits of collaborative working within African heritage organisations and the barriers to engaging audiences with African heritage.

Project description: This is a community research project that explores the work of seven composers of African and Caribbean heritage, from the 18th century to the present day, and share this with the wider community to inspire people to engage with their musical heritage.

Decision: Award grant of £55,426 (76%)

### Cheadle Moon

Applicant: Support Staffordshire

Project description: This project will research and collate information about Mary Blagg, a pioneering female astronomer, to interpret and curate her story and her contributions to early 20th century astronomy.

Decision: Award grant of £24,693 (37%)

### **Midas Touch**

Applicant: Goodnews Community Outreach

Project description: This project will bring Walsall communities together to help raise awareness of Nigerian culture and heritage.

Decision: Award grant of £10,000 (100%)

### **Cultural Exchange: African and Caribbean Music and Dance Project**

Project description: This pilot project will research the heritage of African and Caribbean music and dance at museums in Norwich, Great Yarmouth and London.
