## National Lottery Grants for Heritage

### Celebrating SUES 150 year anniversary

Applicant: Southport University Extension Society

Project Description: To produce learning and promotional materials and an exhibition centred on the history of the University Extension Movement and the continuing educational work of Southport University Extension Society.

Decision: Award grant of £9,750 (100%)

### Heritage Trails – A Journey through Nature

Applicant: Aspire Burnley Community Development

Project Description: To run a walking and exploring programme with sessions focusing on the green lands, woodlands and scenic areas of Burnley and Pendle and giving insights into local heritage.

Decision: Award grant of £10,000 (100%)

### BlackFest – In Conversation – Artists as Activists

Applicant: BlackFest Ltd

Project Description: To uncover the stories of artists, educators and change-makers within Liverpool and record their oral histories to digitise as a podcast, video interview, and archive.

Decision: Award grant of £10,000 (95%)

## **Towards a Sustainable Future for St. Chad's**

Applicant: The Parochial Church Council of the Ecclesiastical Parish of Kirkby

Project Description: Researching ways of making the church more accessible and functional for the benefit of the community through tours, open events, and activity-focused consultation to engage in heritage.

Decision: Award grant of £10,000 (64%)

## **Lancaster Dino Fest – Legacy of Sir Richard Owen**

Applicant: Lancaster BID Ltd

Project Description: To celebrate Lancaster's links with Sir Richard Owen, a renowned palaeontologist, through delivering workshops to primary school-aged children and creating artwork which will form a trail around Lancaster city centre in conjunction with Dino Fest.

Decision: Award grant of £10,000 (50%)

## **Memories of My Mother: Unravelling the Sari Story of Manchester**

Applicant: Creative Design & Manufacture UK Limited

Project Description: Focusing on the rich history and cultural significance of the Sari to Manchester's South Asian community through oral history collection, storytelling, and memory sharing sessions.

Decision: Award grant of £9,965 (100%)

## **If You Know Your History**

Applicant: HYPE Merseyside Ltd

Project Description: To work with local primary schools to research the journey of English football since the creation of a national football league, culminating in a community event.

Decision: Award grant of £9,365 (100%)

## **Passa Passa**

Applicant: For Us and By Us CIC

Project Description: To produce a play based on consultations with individuals from the Windrush generation in Manchester. Including recollections of significant events such as Jamaica's independence from British colonial rule in the 1960s, the emergence of reggae music and the political civil war.

Decision: Award grant of £8,993.00 (98%)

## **A Town of Vikings, Great Grimsby**

Applicant: VESR (Visitor, Economy, Services and Retail Group) CIC

Project Description: To build on the momentum of Grim Falfest and continue to explore local Viking and Saxon heritage through a public engagement event and the development of a co-ordinated programme of projects with existing partners.

Decision: Award grant of £10,000 (100%)

## **Sheffield Historic Buildings Trust – Engaging Communities in Sheffield**

Applicant: Sheffield Historic Building Taskforce Ltd

Project Description: To set up a Building Preservation Trust in order to carry out capital works on buildings at risk and repurpose them for community use, engaging local groups with the process through heritage and skills education and consultation events.

Decision: Award grant of £10,000 (91%)

## **The Future of the Eritrean Coffee Ceremony: Building Bridges Between the Generations**

Applicant: Tyne and Wear Eritrean Community Association

Project Description: To preserve the Eritrean coffee ceremony for younger generations by providing weekly workshops culminating in a celebration event and the creation of a resource library of books, articles, and videos on the history and significance of the ceremony.

Decision: Award grant of £9,999 (100%)

## **Rest Under the Stars: A Cumbrian Journey**

Applicant: Cathedral Church of the Holy and Undivided Trinity of Carlisle

Project Description: To create an immersive touring sound and image installation focusing on the heritage of Carlisle Cathedral.

Decision: Award grant of £9,442 (100%)

## **Write On Your Doorstep**

Applicant: Artfull: Participatory & Community Arts Group

Project Description: To explore Black history in Preston and links to its industrial past through creative responses, visits and the production of a book.

Decision: Award grant of £6,070 (100%)

## **St John's Laundry Heritage Centre**

Applicant: The Parochial Church Council of Waberthwaite

Project Description: To develop a resource centre at the newly renovated Laundry building with display boards, resource boxes for schools and artefacts on display.

Decision: Award grant of £8,250 (100%)

Project Description: To curate and deliver a 'Geostories' programme with communities in Hexham East that includes workshops, volunteer training and a community-curated exhibition.
