Committee Business

1. Chair's Report

Jim Harker, Chair of the Committee for the East Midlands, presented his report.

Atul Patel had been reappointed for another year as NHMF Trustee and would remain a member of the Committee for the East Midlands during that time. Atul was an enthusiastic advocate for the region and members were delighted to note his reappointment.

The Galleries of Justice project in Nottingham would soon be opening with events taking place throughout April. Bridgford Hall, the first complete Heritage Enterprise scheme in the East Midlands, was close to completion and its launch event would be attended by Ros Kerslake in June.

Development activity was levelling over after a busy period. With a lower budget next year, the emphasis was on encouraging quality applications. The Committee noted a high level of success in Boston, a priority development area.

A draft report of the work being undertaken by the University of Northampton had been received and would be presented to the June Committee meeting.

7. Newark Castle Gatehouse Transformation Project

Applicant: Newark & Sherwood District Council

Request: First Round Pass of £900,200 including Development Grant of £84,000 (69%)

Project: To repair and restore the Grade I listed Newark Castle and Gatehouse, to improve the visitor offer at the site. Alongside capital works, the project would develop a sustainable programme of training, volunteering and community involvement activities.

The Committee for the East Midlands considered that the project represented a high priority for support and **AWARDED** a first round pass of £900,200 including a development grant of £84,000 (69% of total eligible development funds).

8. Grants for Places of Worship Applications

9. Sharing Jewish Heritage in Leicester

CEM 2017 (1) 9

Applicant: Leicester Hebrew Congregation

Request: Award grant of £1,157,400 (68%)

Uplift: £297,100 (35%), largely due to underpinning works required to secure the main fabric of the building.

Project: To develop a new education and visitor centre at the Grade II listed Leicester Jewish Congregation Synagogue, situated in the Highfields area of the City. The scheme would celebrate, share and make accessible Leicester's rich Jewish heritage. Proposals would construct a newbuild extension creating a separate entrance for the education and visitor centre, refurbish the schoolrooms and improve access to and within the building through an external access ramp and lift. An education and activity programme would also be delivered.

The Committee for the East Midlands AWARDED a grant of £1,157,400 (68%)

10. Derelict Market Rasen station restoration - Creating managed workspace and providing local employment and a community facility

Applicant: Market Rasen Station Community Project CIC

Request: Award grant of £463,900 (74%)

Uplift: £68,200 (17%) as a result of condition surveys which showed that stonework had significantly deteriorated and required higher level of repairs than was originally envisaged.

Project: An 18 month project to restore and renovate Market Rasen's Grade II Listed former railway station building to provide mixed use workspace and community and visitor facilities. An associated programme of activities would be delivered alongside capital works.

The Committee for the East Midlands AWARDED a grant of £463,900 (74%).

11. Leicester Cathedral Revealed

Applicant: Leicester Cathedral

Request: First Round Pass of £3,325,000, including Development Grant of £330,000 (48%)

Project: A programme of capital works for the Cathedral and its precinct to address repair needs, as well as shortcomings with its services, infrastructure and accessibility. The 1939 Old Song School would be demolished and replaced with a Heritage Learning Centre new build extension. An activities programme, supported by qualified staff and trained volunteers, would be developed.

The Committee for the East Midlands recommended the project as a **HIGH PRIORITY** to the Board.
