1. Chair's report

2. Minutes of last meeting on 3 June 2015

4. Yorkshire and the Humber Regional Overview

The Committee noted the report.

5. Yorkshire and the Humber Budget

CYH 2015 (3) 5

Kathryn Frankish presented the budget paper. There were five first round Heritage Grants applications for decision, with a total first round pass request of £7,613,700, against an indicative budget of £2,666,667, meaning there was competition at first round.

There was also one second round Heritage Grants application and one second round Landscape Partnership application.

The Committee noted the budget paper.

Heritage Grants

7. Humber Bridge and Country Park Experience; HG-14-03201

CYH 2015 (3) 7

East Riding of Yorkshire Council sought a first round pass for the improvement of Humber Bridge Country Park and the restoration of Hessle Whiting Mill, a scheduled ancient monument and Grade

Il listed building. Footpath and other access improvement works would make the park and mill more accessible and new interpretation and signage would be delivered. A programme of community engagement and learning activities would also be delivered.

The Committee agreed that the application represented a medium priority for support and awarded a first round pass of £760,000, including a development grant of £36,000 (80% of total eligible development costs).

8. Ledston Hall public space creation, restoration and engagement; HG-14-07906

CYH 2015 (3) 8

The Wheler Foundation sought a first round pass of £1,730,300, including a development grant of £10,000 (17% of total eligible development costs) to undertake capital works at the Grade I listed Ledston Hall, located within a Grade II* registered historic park and gardens in Ledston, near Castleford. The principal rooms of most historic interest would be restored and made available for community, educational and commercial use. A number of items of art and furniture, originally displayed at the hall, would be returned for public viewing in these rooms. An activity programme would also be delivered.

Overall, the Committee agreed that the application represented a low priority for support and rejected it.

9. Coalfield Conversations: Increasing Visitor Engagement through Facilitated Surface Interpretation; HG-14-09364

CYH 2015 (3) 9

National Coal Mining Museum for England sought a first round pass to overhaul the visitor offer on the site's surface, to match the quality and popularity of the underground offer. The project would provide new face-to-face interpretation, expand the volunteer programme, renew signage and interpretation, and reconfigure the visitor welcome area.

The Committee noted the unexpected resignation of the museum's director, which represented a material change to the circumstances of the application.

The Committee deferred the application.

10. York Guildhall and Riverside - Telling York's Story from its very heart; HG-15-00467 CYH 2015 (3) 10

City of York Council sought a first round pass £1,687,000, including development grant of £56,000 (24% of total eligible development costs) to open up the Grade I listed York Guildhall as a heritage visitor attraction, following the Council's move to new offices. The building would be conserved and opened up to the public to a greater extent than ever before. The heritage centre would tell the story of the City of York and showcase its important archaeological and other historic artefacts. Flexible events space would also be developed in order to provide a sustainable future income stream. Volunteering and education facilities would also be delivered.

The Committee rejected the application.

11. Stories and Treasures of Street and Dale: Transforming Craven Museum & Gallery; HG-15-00517

CYH 2015 (3) 11

Craven Museum and Gallery sought a first round pass to reconfigure, re-interpret and enliven the visitor offer at the museum. Capital works would reconfigure two floors of Skipton Town Hall to deliver a refurbished museum, improved visitor facilities, temporary exhibition space and collections storage space. The Tourist Information Centre would also be relocated to the building's ground floor. The works would allow more of the museum's exceptional collection to be displayed,

and make it accessible to a larger number of visitors. An activity programme would also be delivered.

The Committee agreed that the application represented a high priority for support and awarded a first round pass of £1,599,500, including development funding of £98,000 (70% of total eligible development costs).

12. Prioritisation of first round items

Oral

With reference to the available budget and the anticipated pipeline for the next meeting, and having already agreed to reject item 10 (York Guildhall and Riverside) and defer item 9 (Coalfield Conversations), the Committee awarded first round passes to items 7 (Humber Bridge and Country Park Experience) and 11 (Craven Museum and Gallery). They then agreed to reject item 8 (Ledston Hall) which had been identified as a low priority for support.

Heritage Grants

13. The Living Heritage of the River Don; HG-12-10335

CYH 2015 (3) 13

The Don Catchment River Trust sought a grant to conserve the natural heritage of the River Don and engage and educate people with that heritage. Fish passes would be installed at weirs to allow salmon and other fish to return to the upper reaches of the river. A riverside trail would be created, which would feature interpretation to engage people with the rich natural and industrial heritage of the area. Volunteering and activities would also be delivered.

The Committee had awarded a first round pass of £1,272,000, including development funding of £81,500 in March 2014.

The Committee awarded a grant of £1,190,200 (84% of total eligible project costs).

Landscape Partnership

14. Ingleborough Dales Landscape Partnership; LP-12-11401

CYH 2015 (3) 14

Yorkshire Dales Millennium Trust sought a grant for a landscape partnership covering 128 km² of the Craven district of the Yorkshire Dales National Park. This landscape featured a variety of significant natural and human features, and was at risk of deterioration. A programme of training and volunteering opportunities would be delivered and both local people and visitors would be engaged in learning about and caring for the landscape.

The Board had awarded a first round pass of £2,111,000, including a development grant of £99,100 in October 2013.

The Committee awarded a grant of £2,018,800 (77% of total eligible project costs).
