Kathryn Frankish presented the budget paper. The Committee noted that there were three first round applications recommended for support, with a combined first round request of £3,678,700, against the remaining first round budget of £3,397,800.

The Committee noted that there was sufficient grants budget to fund all second round applications which met the required quality threshold.

## SF4 First round applications for discussion and decisionHeritage Grants

### 6. Throwing Light on our History; HG-14-00954

Halifax Minster sought a first round pass of £1,488,400, including development funding of £118,200 (88% of total eligible development costs) to improve facilities for visitors, education, collections and archives. Conservation works would also take place to improve the physical condition of this Grade I listed church.

### CYH 2015 (1) 6

The Committee agreed that the application represented a medium priority for support and **REJECTED** it in the light of the available budget.

### 7. The Holocaust Heritage and Learning Centre; HG-14-05492 CYH 2015 (1) 7

Holocaust Survivors Friendship Association sought a first round pass to create a high quality, accessible Holocaust heritage and learning centre at the University of Huddersfield. The project would capture the testimonies of Yorkshire Holocaust survivors and make these accessible for future generations. Memories, archive materials and objects would be interpreted and displayed, using technology where appropriate. Volunteering and training opportunities would be delivered.

The Committee agreed that the application represented a high priority for support and **AWARDED** a first round pass of £520,000 including development funding of £59,700 (90% of total eligible development costs).

### 9. A Healthy Future for Thackray Medical Museum; HG-13-20806 CYH 2015 (1) 9

Thackray Museum sought a first round pass to refresh exhibitions and displays at the Grade II listed medical museum. The physical fabric of the building would be conserved to prevent water ingress and carry out necessary repair work. Visitor facilities, including the main entrance would be enhanced and a programme of events and activities delivered.

The Committee agreed that the application represented a high priority for support and **AWARDED** a first round pass of £1,670,300, including development funding of £154,600 (80% of total eligible development costs).

### 10. Prioritisation of first round items

With reference to the available budget, the Committee agreed to award first round passes to the two applications which had been identified as high priorities for support and to reject item 6 in the light of the available budget.

### Heritage Grants

### 11. Creating the Paul Iles Learning Centre; HG-11-00249 CYH 2015 (1) 11

The Georgian Theatre Trust sought funding to expand and develop the learning and participation programme at the Georgian Theatre Royal so that people could better appreciate the Theatre's unique historic nature. In addition, the physical and intellectual access to the Theatre would be improved through the opening up of a passageway behind the Theatre. The Theatre was Grade I listed and Britain's most complete Georgian playhouse. It also held the oldest surviving theatre scenery, dating from the early 19th Century.

The Committee had awarded a first round pass of £755,800, including development funding of £121,600 (91% of total eligible development costs) in September 2012.

The Committee agreed that the application represented a high priority for support and **AWARDED** a grant of £286,400 (55% of total eligible project costs).

### 12.Jewish Heritage- A Journey through Time; HG-11-06412CYH 2015 (1) 12

Chabad Lubavitch (UK) Limited sought a grant of £379,500 (89% of total eligible project costs) for a project focusing upon the provision of a facility for young people over the age of 11 and adults to learn about Jewish heritage in the UK in an age appropriate, interesting and engaging way. The

project constituted an extension to the entrance hall at the rear of the Chabad Lubavitch Centre in Leeds, the mounting of a multi-media exhibition and the display of artefacts. Learning, training and community engagement opportunities would also be provided.

The Committee had awarded a first round pass of £378,600, including development funding of £32,500 in March 2013. The Committee noted that the proposals now included the construction of a Mikveh as part of the educational offer. A Mikveh was a traditional way of achieving ritual purification through immersion in pure water. The proposed Mikveh at the centre would take the form of a small swimming pool-like structure which would be fed with rainwater. This new build element had not been included at first round.

The Committee **REJECTED** the application.

### Heritage Grants

### 13. Opening Doors; HG-12-09897

City of York Council sought a grant to widen public access and community engagement with the Grade I listed Mansion House, an underused resource within York city centre. The proposals would deliver conservation and capital works to protect the collections at the Mansion House and improve public access. Education and interpretation would also be delivered to better utilise the visitor offer.

The Committee had awarded a first round pass of £1,096,800, including development funding of  $\pounds$ 76,500 (72% of total eligible development costs) in September 2013.

The Committee agreed the application represented a high priority for support and **awarded** a grant of £1,198,700 (70% of total eligible project costs).

### 14. Prioritisation

Having already agreed to reject item 12, the Committee awarded grants to the other two second round applications, both of which had been identified as high priorities for support.

Civic Voice in partnership with the Institute of Historic Building Conservation, North of England Civic Trust and the Architectural Heritage Fund, with the support of English Heritage sought a first round pass of £2,690,700 including a development grant of £95,700 towards a four-year English cross-territory project to survey the national collection of Grade II assets using volunteers with the support of historic environment specialists.

# 18. The history and heritage of the National Union of Students, a historical archive.(cross territory); HG-13-10719

The National Union of Students (NUS), lead partner for a consortium, sought a first round pass of £445,900 including a development grant of £45,000 towards a project which aimed to identify, collect, catalogue, preserve and make available archives relating to the UK's student movement.

The Committee discussed the application and made a recommendation to the Board

### 19. Rambert at 90 (cross territory); HG-14-07342 CYH 2

Rambert Dance Company and Rambert Trust Ltd sought a first round pass of £339,400 including a development grant of £31,800 towards a project to celebrate the 90th anniversary of the Rambert Dance Company through a touring exhibition and activity project in support of their 2016/17 tour. An exhibition covering Rambert and its history would be developed and displayed at the Lowry, Salford; this would include materials such as photographs, programmes and costumes held in the Rambert archive.

Temple Southbank Trust sought a first round pass of £13,548,000, including development funding of £649,000 (66% of total eligible development costs) to repair, conserve and restore Temple Mill in Leeds and create an economically sustainable cultural and heritage visitor destination. The Grade I listed Temple Mill and associated Grade II listed gatehouse building were both of high heritage significance and in a poor state of repair.
