#### **Committee Business**

#### 1. Chair's Report

The Committee thanked Gary Verity for his time as Chair of the Committee. His term would come to an end on 31 March 2017.

The Chair informed the Committee that David Renwick would start in June as the new Head of Region for Yorkshire and the Humber.

#### 2. Minutes of last meeting on 8 December 2016

Keith Sweetmore informed the Committee that as an Engagement Manager for the National Archives he had received informal briefings about item 7. *West Yorkshire Archives Kirklees at Heritage Quay.* However, he had not been involved in the planning or development of the project, nor offered any advice or guidance in relation to it. The Committee was content this did not constitute a conflict of interest.

#### 7. West Yorkshire Archives Kirklees @ Heritage Quay, HG-16-06037

Applicant: University of Huddersfield

Project: The project aims to open up and secure the long-term future of the historical physical archives of Kirklees by uniting them on one site in Kirklees. Alongside capital works there would be a two-year Activity Plan, supported by the development of a volunteering and cataloguing programme.

The Committee for Yorkshire and the Humber considered the project a high priority for support and **AWARDED** a first round pass of £1,995,800 including development grant of £80,700 (82% of total eligible development costs)

#### 8. Lending a New Lease of Life to Walkley Library; HE-16-05537

Applicant: Walkley Carnegie Library

Project: To create a sustainable business model that protects the long term future of the grade II listed Walkley Carnegie Library building and library service, whilst making a positive contribution towards the economy and recreational needs of the local community. Alongside a programme of repairs there would be opportunities for the community to develop heritage skills and to learn about the heritage of the building.

The Committee for Yorkshire and the Humber considered the project a high priority for support and **AWARDED** a first round pass of £1,329,000 including a development grant of £67,000 (66% of total eligible development costs)

#### 9. The Heritage of Hull Kingston Rovers; HG-16-05286

Tony Collins left the room for this item

Applicant: Hull Kingston Rovers Community Trust

Project: This three-year project would preserve and share the heritage of Hull Kingston Rovers Rugby League Football Club (HKR). The project would collate, catalogue, preserve and promote the heritage of the club, setting it against the industrial and cultural heritage of Hull. The project would also provide training opportunities for 500 people and create an interactive touring exhibition to be taken to local museums, Hull History Centre, pubs, libraries, schools, care homes and community venues.

The Committee for Yorkshire and the Humber considered the project a high priority for support and **AWARDED** a first round pass of £224,600 including a development grant of £46,900 (94% of total eligible development cost)

#### 10. Increasing knowledge of and skills in the craft of quilting and its heritage; HG-16-05915

CYH 2017 (1) 10

Applicant: The Quilters' Guild of the British Isles

Request: First round pass of £511,900 including a development grant of £15,000 (95% of total eligible development costs)

Project: To reverse the decline in traditional quilting skills and audiences, the project would deliver better digital access and interpretation, improved exhibitions, enhanced merchandising, oral history work, training and improved communication.

The Committee for Yorkshire and the Humber **rejected** the application.

#### 11. Prioritisation of first round items

The Committee prioritised the applications as follows:

Item 7. West Yorkshire Archives Kirklees @ Heritage Quay, item 8. Lending a New Lease of Life to Walkley Library and item 9. The Heritage of Hull Kingston Rovers were high priorities for support and awarded a first round pass.

Item 10, *Increasing knowledge of and skills in the craft of quilting and its heritage* was a low priority for support and was rejected.

#### 12. Saltaire Stories; HG-15-00055

Applicant: Saltaire World Heritage Education Association

Project: To improve care, access and engagement at the Saltaire Archive, located at Shipley College in Saltaire. The archive contained material dating back to the 1850s and was currently not well used or understood. The project would train volunteer archivists, catalogue and conserve the collection, digitise key items, deliver educational activities and establish an educational website.

First round decision: First round pass of £123,400 including a development grant of £11,700 (72% of total eligible development costs) in November 2015

Uplift: £23,900 (21%)

The Committee for Yorkshire and the Humber awarded a grant of £135,600 (90%)

### 15. Hull: Yorkshire's Maritime City; HG-15-03524

Applicant: Hull City Council

Request: First round pass of £14,999,900 including a development grant of £1,368,400 (56% of total eligible development costs)

Project: To restore key maritime heritage assets in Hull. The project would redevelop five maritime assets across Hull: the transformation of the Grade 2\* Maritime Museum with a new architectural and exhibition scheme; the creation of a collections store at the Dock Office Chambers; the conservation of two historic vessels – the Arctic Corsair and the Spurn Lightship, and; the creation of a visitor orientation centre and dry-berth at the derelict North End Shipyard. Capital works would be complimented by a range of activities.

### 16. Ripon Cathedral Renewed; HG-16-04609

Applicant: Dean & Chapter, Ripon Cathedral

Request: First round pass of £7,987,700 including development grant of £715,100 (63% of total eligible development costs)

Project: The project would aim to secure the sustained conservation of and wider access to Ripon Cathedral through a range of repair and conservation works and new build, supported by activities and works to improve interpretation and the visitor experience.
